# ANNUAL TOWN MEETING TOWN OF WHATELY April 26, 2016

Pursuant to the recorded warrant the annual meeting of the Town of Whately held at the Whately Elementary School, 273 Long Plain Road was called to order Tuesday, April 26, 2016 at 7:00 p.m. by Moderator Richard Smith. Town Clerk, Lynn M. Sibley read the Constable's return of the warrant. Virginia Allis and Maryellen Cranston acted as checkers and assigned voting placards to those voters attending the meeting. Maximum attendance was 113 voters. The Moderator appointed Robert Halla and Charles Peter Williams to serve as counters. This meeting was being broadcast by FCAT as well.

Clerk's Note: Jonathan Edwards, Chair of the Selectboard acknowledged Bill Smith who retired recently as the 2015 recipient of the Annual Report dedication. Chair Edwards spoke highly of Bill's years of service to the town as Water Superintendent and Frontier School Committee member. Jonathan also commended the work of all the town employees.

Article 1. Upon motion made and seconded, it was

Voted that the town accept the Annual Reports of the officers of the Town, and to hear any other reports of the Boards and Committees.

Moderator declared article passed in the affirmative.

Article 2. Upon motion made and seconded, it was

Voted that the town authorize the Town Treasurer, with the approval of the Board of Selectmen, to borrow money from time to time in anticipation of the revenue of the Fiscal Year beginning July 1, 2016, in accordance with the provisions of General Laws, Chapter 44, Section 4, and to renew any note or notes as may be given for a period of less than one year, in accordance with the provisions of General Laws, Chapter 44, Section 17.

Moderator declared article passed in the affirmative

Article 3. Upon motion made and seconded, it was

Voted that the town authorize the Town Treasurer, with the approval of the Board of Selectmen, to enter into compensating balance agreements with banking institutions having their principal offices in the Commonwealth during Fiscal Year 2017, as permitted by General Laws Chapter 44, Section 53F.

Moderator declared article passed in the affirmative

Article 4. Upon motion made and seconded, it was

Voted that the town apply for, accept, and expend any federal, state or private grant monies on behalf of the Town and authorize the Town Treasurer with the approval of the Board of Selectmen to borrow in anticipation of reimbursement.

Moderator declared article passed in the affirmative

Article 5. Upon motion made and seconded, it was

Voted that the town authorize revolving funds for certain Town departments under General Laws Chapter 44, Section 53 E <sup>1</sup>/<sub>2</sub> for the fiscal year beginning July 1, 2016.

### The following eleven (11) articles are recommendations of the Capital Planning Committee:

Article 9: Upon motion made and seconded, it was

Voted to borrow the sum of **\$145,000** for the purchase of a dump truck for the Highway Department as part of the 2017 Capital Improvement Plan, and authorize the Treasurer, with the approval of the Selectboard, to issue any bonds or notes that may be necessary for that purpose, as authorized by General Laws Chapter 44, §7 (9), or any other general or special law, for a period not to exceed 3 years.  $2/3^{rd}$ 's vote required

Moderator declared vote passed unanimously

Article 10: Motion was made and seconded that the Town vote to transfer from available funds (FREE CASH) the sum of \$13,000 for paving the Highway Department lot to the Salt Shed.

An Amendment was made and seconded as follows:

I move that the Town vote to transfer from available funds (FREE CASH) the sum of \$13,000 for paving the Highway Department lot to the Salt Shed and for repairs to the Town Highway Garage building.

There was much discussion regarding this amendment. The Highway Superintendent reported that if this paving project is done at the same time as the police parking lot and the regular road paving, there could be as much as \$5,000 remaining in this line item. The amendment asks that this balance be used to start on repairs to the Town Highway Garage. The argument against this amendment was that the repairs to the Highway Garage should be evaluated and brought to the Capital Planning Committee separately from this article.

A vote was taken on the amendment and it failed.

A vote was taken on the original motion and it was

Voted that the town transfer from available funds (FREE CASH) the sum of **\$13,000** for paving the Highway Department lot to the Salt Shed.

Moderator declared article passed in the affirmative

Article 11: Upon motion made and seconded, it was

Voted that the town transfer from available funds (FREE CASH) the sum of **\$18,000** to purchase an emissions exhaust system for the Fire Department.

Moderator declared article passed in the affirmative

Article 12: Upon motion made and seconded, it was

Voted that the town transfer from available funds (FREE CASH), the sum of **\$10,000** to complete repairs to the Police Department building, by installing fencing, lighting, and completing the paving in the parking lot and walkway areas surrounding the building.

Article 13: Upon motion made and seconded, it was

Voted that the town transfer from available funds (FREE CASH), the sum of **\$35,000** to replace a model year 2009 Cruiser for the Police Department.

Moderator declared article passed in the affirmative

Article 14: Upon motion made and seconded, it was

Voted that the town transfer from available funds (FREE CASH), the sum of **\$15,500** for repairs to the roof and gutters, and entrance improvements at the S. White Dickinson Library.

Moderator declared article passed in the affirmative

Article 15: Upon motion made and seconded, it was

Voted that the town transfer from available funds (FREE CASH), the sum of **\$3,000** to purchase a storage shed for the Blue School Field, located at 219 Christian Lane.

Moderator declared article passed in the affirmative

Article 16: Upon motion made and seconded, it was

Voted that the town transfer from available funds (FREE CASH), the sum of **\$6,000** to purchase and install padding at the Whately Elementary School gymnasium.

Moderator declared article passed in the affirmative

Clerk's Note: It was noted that this \$6,000 will be supplemented by other funds from other sources.

Article 17: Upon motion made and seconded, it was

Voted that the town transfer from Water Department Retained Earnings (Free Cash) the sum of **\$10,000** to complete the purchase of a pump house generator for the Water Department.

Moderator declared article passed in the affirmative

Article 18: Upon motion made and seconded, it was

Voted that the town transfer from Water Department Retained Earnings (Free Cash) the sum of **\$5,000** for the replacement of the Water Department Truck.

Moderator declared article passed in the affirmative

Article 19: Upon motion made and seconded, it was

Voted that the town transfer from Water Department Retained Earnings (Free Cash) the sum of **\$15,000** for cleaning and waterproofing the Water Department Storage Tank.

### The following six (6) articles are recommendations of the Community Preservation Committee:

#### Article 20: Upon motion made and seconded, it was

Voted that the town hear and act, pursuant to G.L. c.44B, on the report of the Community Preservation Committee for the Fiscal Year 2017 Community Preservation Budget and vote to appropriate or reserve from the **Community Preservation Fund** a sum of money in the amounts recommended by the Community Preservation Committee for committee administrative expenses, community preservation projects and other necessary and proper expenses in the fiscal year beginning July 1, 2016, including debt service for any approved Community Preservation projects, with each item to be considered a separate appropriation;

Moderator declared article passed in the affirmative

Article 21: Upon motion made and seconded, it was

Voted that the town, pursuant to G.L. c.44B, to appropriate and transfer from the Community Preservation Fund Open Space Reserve and the Community Preservation Fund Budgeted Reserve the sum of **\$16,000** as the Town's match for a permanent Agricultural Preservation restriction on 17.6 acres of farmland located on the west side of Long Plain Road north of the Whately Elementary School, and shown on Assessors' Map 26 as Lot 24, currently owned by Ed and John Smiarowski and Beverly and Donald Wilson, upon such terms and conditions as the Selectboard, in consultation with the Agricultural Commission, shall deem appropriate.

Moderator declared article passed in the affirmative

Article 22: Upon motion made and seconded, it was

Voted that the town, pursuant to G.L. c.44B, to appropriate and transfer from the Community Preservation Fund Historic Resources Reserve and the Community Preservation Fund Budgeted Reserve the sum of **\$30,000** for the preservation and repairs of compromised and deteriorating grave stones in Town cemeteries identified in the 2013 Master Plan provided by Gravestone Services of New England; work to be done under the direction of the Cemetery Commissioners.

Article 23: Upon motion made and seconded, it was

Voted that the town, pursuant to G.L. c.44B, to appropriate and transfer from the Community Preservation Fund Budgeted Reserve the sum of **\$84,000** to fund the preparation of bid-ready construction documents, through a formal request for proposals process, for the rehabilitation of the Town Hall building on Chestnut Plain Road, to serve as a community center for social, recreational and cultural use.

**Clerk's Note:** Alan McCardle, chair of the Historical Commission, gave a power point presentation. There was much discussion regarding this article. A motion was attempted to postpone action but the original motion was already made and seconded so the Moderator declared the motion to be out of order. Opposition felt that it is not known on whether the townspeople want to continue the rehab on this building or how much of a financial burden people are willing to accept. Opposition felt that these things should be decided before money is spent on these documents. Proponents felt that in order to give voters the accurate information the bid ready documents need to be created so final costs can be determined. Proponents also noted that grants can't be applied for without the bid ready documents. There was also some debate on the tax implications but this article is being funded through CPA. Funding availability for the actual project won't be known until the documents are completed and the project is bid.

A vote of voting placards was taken and there were 69 affirmative votes and 34 nay votes. The Moderator declared article passed in the affirmative

Article 24: Upon motion made and seconded, it was

Voted that the town, pursuant to G.L. c.44B, close the following CPA accounts, and return the funds to the **following reserves**:

Article 25: Upon motion made and seconded, it was

Voted that the town transfer from available funds (FREE CASH), the sum of **\$115,000** for office renovations at the Whately Town Office Building.

The Moderator declared article passed in the affirmative

Article 26: Upon motion made and seconded, it was

Voted to authorize the Selectboard to petition the General Court for special legislation to allow Peter Hannum, a Town of Whately call firefighter, notwithstanding the provisions of any general or special law to the contrary, to serve in such position until the age of 70, or until the date of his retirement or non-reappointment, whichever occurs first; provided, however that no deductions from the regular compensation of Peter Hannum shall be made under chapter 32 of the General Laws subsequent to his reaching the age of 65 in connection with his service to the Town for retirement or pension purposes; and further provided, that the General Court may make clerical and editorial changes of form only to the bill unless the Selectboard approves amendments to the bill prior to enactment by the General Court, and to authorize the Selectboard to approve such amendments which shall be within the scope of the general public objectives of the petition.

The Moderator declared article passed in the affirmative

### Article 27: Article was withdrawn by the Board of Selectmen.

This article pertained to authorizing the Selectboard to act in the best interests of the Town, to negotiate in order to make changes to the South County Emergency Medical Services (SCEMS) Inter-Municipal Agreement (IMA).

Article 28: Upon motion made and seconded, it was

Voted to authorize the Board of Assessors to transfer from Free Cash, the sum of **\$200,000** to reduce the tax levy for FY17.

Upon motion made and seconded, it was

Voted to adjourn without date at 8:30 p.m.
