Minutes of the January 14, 2019 Meeting 5 pm, Whately Town Hall

The minutes of the December 5 meeting were approved as amended.

Toro Verde Marijuana Retailer site plan review

It was unanimously agreed that since there are no external changes to the property the Historical Commission would not submit comments. Donna will notify the Planning Board.

Haydenville Road Reconstruction project

The group reviewed a December 18 letter from Hoyle and Tanner engineers regarding the DOT project and determined that there was no adverse impact on the West Whately National Register district. Donna will write to Hoyle and Tanner with copies to MHC and Mass. DOT Cultural Resources department.

MHC inventory forms

Susan presented the spreadsheet of properties previously identified as either having changed over time or not having occupants on Whately's Street List (attached). It showed the buildings we identified as having been demolished. Most of the remaining on the list are standing and have out of town owners. Letters to new historic homeowners

Donna noted that 101 Chestnut Plain Road, the c1762 Captain Salmon White house had recently sold. The group agreed that it would be appropriate to write new owners to point out the resources available to tell them about their house's history and that of the town. Donna will do this one.

North Street historic area

Judy commented that it would have given the North Street Historic Landscape more protection from the proposed solar project if there had been an inventory form for the

area. After discussion about the best way to get such a form prepared, it was agreed to apply for a MHC preservation planning grant in the fall. We will leave it to the professional grant writer to determine whether there should be one or two North Street areas.

On-line maps of Whately's historic areas

Alan noted that it would be helpful to have links to maps delineating the historic areas and districts in Whately. We agreed to bring maps of as many districts as possible to the next meeting.
