To either of the Constables of the Town of Whately in the County of Franklin, GREETING:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said town, qualified to vote in elections and in town affairs, to meet at the Whately Elementary School, 273 Long Plain Road in Whately on Tuesday, the twenty-fifth day of April next, at seven o'clock in the evening, then and there to act on the following articles:

Article 1.

To see if the Town will vote to accept the Annual Reports of the Officers of the Town, and to hear any other reports of the Boards and Committees, or take any other action relative thereto.

Article 2.

To see if the Town will vote to authorize the Town Treasurer, with the approval of the Selectboard, to borrow money from time to time in anticipation of the revenue of the fiscal year beginning on July 1, 2017, in accordance with the provisions of G.L., c. 44, § 4, and to renew any note or notes as may be given for a period of less than one year, in accordance with the provisions of G.L. c. 44, § 17, or take any other action relative thereto.

Article 3.

To see if the Town will vote to authorize the Town Treasurer, with the approval of the Selectboard, to enter into compensating balance agreements with banking institutions having their principal offices in the Commonwealth of Massachusetts during the fiscal year beginning on July 1, 2017, as permitted by G.L. c. 44, § 53F, or take any other action relative thereto.

Article 4.

To see if the Town will vote to apply for, accept, and expend any federal, state or private grant monies on behalf of the Town and to authorize the Town Treasurer with approval of the Selectboard to borrow in anticipation of reimbursement, or take any other action relative thereto.

Article 5.

To see if the Town will vote to amend the General Bylaws of the Town by inserting a new Part I: Chapter 46, Revolving Funds, to establish and authorize revolving funds for use by certain Town departments, boards, committees, agencies or officers under G.L., c. 44, § 53 $E\frac{1}{2}$ as follows, in italics:

CHAPTER 46 - REVOLVING FUNDS

§ 46-1. Purpose.

This by-law establishes and authorizes revolving funds for use by Town, departments, boards, committees, agencies and officers in connection with the operation of programs or activities that generate fees, charges or other receipts to support all or some of the expenses of those programs or activities. These revolving funds are established under and governed by General Laws Chapter 44, $53E\frac{1}{2}$

§ 46-2. Expenditure Limitations.

A department or agency head, board, committee or officer may incur liabilities against and spend monies from a revolving fund established and authorized by this by-law without appropriation subject to the following limitations:

- (A) Fringe benefits of full-time employees whose salaries or wages are paid from the fund shall also be paid from the fund.
- (B) No liability shall be incurred in excess of the available balance of the fund.
- (C) The total amount spent during a fiscal year shall not exceed the amount authorized by Annual Town Meeting on or before July 1 of that fiscal year, or any increased amount of that authorization that is later approved during that fiscal year by the Selectboard and Finance Committee.

§ 46-3. Interest.

Interest earned on monies credited to a revolving fund established by this by-law shall be credited to the general fund.

§ 46-4. Procedures and Reports.

Except as provided in General Laws Chapter 44, § 53E½ and this by-law, the laws, by-laws, rules, regulations, policies and procedures that govern the receipt and custody of Town monies and the expenditure and payment of Town funds shall apply to the use of a revolving fund established and authorized by this by-law. The Town Accountant shall include a statement on the collections credited to the fund, the encumbrances and expenditures charged to each fund and the balance available for expenditure in the regular report the Town Accountant provides the department, board, committee, agency or officer on appropriations made for its use.

§ 46-5. Authorized Revolving Funds.

The Table below establishes:

- (A) Each revolving fund authorized for use by a Town department, board, committee, agency or officer;
- (B) The department or agency head, board, committee or officer authorized to spend from each fund;
- **(C)** The fees, charges and other monies charged and received by the department, board, committee, agency or officer in connection with the program or activity for which the fund is established that shall be credited to each fund by the Town Accountant;
- (D) The expenses of the program or activity for which each fund may be used;
- (E) Any restrictions or conditions on expenditures from each fund;
- (F) Any reporting or other requirements that apply to each fund; and
- (G) The fiscal years each fund shall operate under this by-law.

Article 31. (as submitted)

To see if the Town will vote to pass the following resolution:

Whereas the influence of money in political campaigns exerts an undue influence on electoral outcomes that weakens the democratic principle of one person one vote and;

Whereas the recent general election has made it clear that our election system is subject to novel forms of manipulation and influences it was never designed to resist and;

Whereas the practice of gerrymandering and apportionment of political districts by partisan committees distorts democratic representation and ensures continuance of domination of the electoral process by incumbents of the majority party and;

Whereas current party rules and election laws do not adequately address issues of conflicts of interest on the part of candidates for public office.

We instruct our elected representatives at both the state and national levels to

Stop the Corrosive Influence of Money on Politics by:

- Prohibiting politicians from raising money from lobbyists. Members of Congress and candidates for federal
 office/state office may not accept contributions in connection with an election from a lobbyist.
- Prohibiting lobbyists from bundling campaign contributions in connection with an election for public office.
- Closing the "Revolving Door "by extend the existing revolving door limitations applicable to Members of Congress and congressional staff to 5 years for former Members, and 5 years for former congressional staffers who are either (1) paid at a rate of 75% or more of a Member's salary, or (2) whose duties are not primarily secretarial in nature. And by prohibiting Members of Congress and senior congressional staff from negotiating or having any arrangement concerning prospective private employment, including engaging in any preliminary or exploratory discussions regarding such employment, while a Member of Congress or senior congressional staff. (This applies to federal representatives.)
- Prohibiting Members of Congress from engaging in political fundraising and soliciting between 9:00 a.m. and 6:00 p.m. on any day in which their House of Congress is in session and is not adjourned or in recess for that entire day, and during any other hours in which the Member's House of Congress or any committee or subcommittee thereof of which they are a member is conducting business. (Applicable to federal representatives.)
- Prohibiting candidates for elected office from not revealing financial information including income tax statements.
- Requiring automatic electronic disclosure of political fundraising and expenditures over \$200.
- Enacting the Democracy is Strengthened by Casting Light on Spending in Elections (DISCLOSE) Act of 2015, S. 229, H.R. 430, 114th Cong, to end dark and grey money.
- Require disclosure of bundlers of contributions. Require incumbent federal officials and
 candidates for federal office to disclose the identity of any individual who is authorized by or known to
 the official or candidate to collect and transmit contributions to their
 campaign committee or leadership PAC, regardless of whether or not the individual is a lobbyist.

Minimize the Likelihood of Conflicts of Interest by:

- Instituting an "open books" policy for candidates for public office.
- Requiring candidates provide complete transparency with regard to their financial interests including, but not limited to, disclosure of their state and federal income taxes.

End Gerrymandering by:

 Transferring all authority over redistricting to an independent, fully transparent commission that must follow strict guidelines to ensure accurate representation for all voters, regardless of political party, and to be in full compliance with the Voting Rights Act.

Let all voters participate in open primaries

• By making all candidates for the same office compete in a single, open primary in which all registered voters may participate. The four candidates with the most votes will proceed to the general election. On the primary ballot, allow candidates to display their party preference, and allow parties to display their chosen nominee(s). Establish meaningful thresholds for the number of signatures required to be collected by volunteers in order for a candidate to appear on the ballot.

Let voters rank their top candidates using ranked choice voting and avoid spoilers

 By using ranked choice voting in all elections so voters may rank candidates in order of preference and not be concerned about voting for "spoiler" candidates.

Fix the Federal Election Commission's Coordination Regulations

 The FEC's current coordination regulations permit extensive collaboration between candidates and supposedly "independent" Super PACs. Amend the Federal Election Campaign Act to create reasonable presumptions of coordination under which an expenditure made by a Super PAC is treated as a contribution to the candidate.

NOW, THEREFORE, BE IT RESOLVED by the citizens of the Town of Whately, Massachusetts that we support tough new anti-corruption laws to close loopholes in Massachusetts' campaign finance regulations that currently allows unregulated out-of-state money to infiltrate state and local elections; and we support the goals outlined in the American Anti-Corruption Act to remove the corrupting influence of money on our political system. The Act prohibits politicians from taking campaign money from special interest groups including private industries and unions; increases transparency for campaign funding; empowers all voters through a tax rebate voucher to contribute to the candidates they support; prohibits representatives and senior staff from all lobbying activity for five years once they leave office; and places limits on superPACs.

BE IT FURTHER RESOLVED that the citizens of the Town of Whately implores our elected representatives in Boston, State Senator Rosenberg and Rep. Kulik and in Washington, Sen. Edward Markey and Sen. Elizabeth Warren and Rep. James McGovern (or their successors) to lead this effort to enact these initiatives in Massachusetts and in the U.S. Congress.

BE IT FURTHER RESOLVED that the Clerk of the Town of Whately is hereby directed to give notice to the above representatives by sending a certified copy of this resolution to each of them.

Article 32. (as submitted)

To see if the Town will vote to pass the following resolution:

WHEREAS climate change poses a serious threat to the Town of Whately in terms of the economy, public health, and the environment;

AND WHEREAS as a result of climate change, the Northeast is experiencing warming temperatures and a large increase in the amount of rainfall measured during heavy precipitation events;

AND WHEREAS more frequent heat waves in the Northeast are expected to increasingly threaten human health through more heat stress, droughts, and air pollution;

AND WHEREAS sea level rise and more frequent heavy rains are expected to increase flooding and storm surge, threatening people and infrastructure, necessitating increased costs for damage control;

AND WHEREAS as temperatures rise, agriculture will likely face reduced yields, potentially damaging livelihoods and the regional economy;

AND WHEREAS Carbon Fee, Cap and Dividend will significantly reduce carbon emissions, create jobs, grow the economy, save lives, and protect households from higher energy prices;

AND WHEREAS most economists, from conservative to liberal, agree that the most cost-effective way to cut carbon pollution is to add a fee that steadily raises the price of fossil fuels,

AND WHEREAS legislation addressing climate change should not economically burden Whately and its citizens;

AND WHEREAS Carbon Fee, Cap and Dividend will protect lower and middle-income households, as two thirds of families will break even or receive more in dividends than they would pay for in higher living expenses;

AND WHEREAS Carbon Fee, Cap and Dividend will create jobs, as the dividend puts money back into local economies;

AND WHEREAS Carbon Fee, Cap and Dividend is a market-based solution in which a desired cap is put on carbon emissions along with a fee levied on carbon-based fuels as they come out of the ground or as they are imported, with all monies returned in equal per person shares to households as a dividend, thus leveraging market forces that encourage investments in increased energy efficiency and alternate sources of energy by both industry and consumers;

AND WHEREAS Carbon Fee, Cap and Dividend will employ a "border adjustment" to protect domestic businesses. The "border adjustment" will use import/export fees and rebates to neutralize any impact to the cost of domestically produced products, and incentivize other states to adopt a comparable carbon fee;

AND WHEREAS in the absence of federal Carbon Fee, Cap and Dividend, the Commonwealth of Massachusetts can pass state Carbon Fee, Cap and Dividend (or "Rebate"),

THEREFORE, BE IT RESOLVED, THAT THE TOWN OF Whately calls upon the Massachusetts Legislature and the United States Congress to implement Carbon Fee, Cap and Dividend (or "Rebate"), placing a cap on carbon emissions along with a fee on carbon-based fuels that rises as necessary to ensure the desired cap is met gradually and predictably, and returning all fees collected, minus administrative costs, to households.

AND BE IT FURTHER RESOLVED THAT UPON PASSAGE the Whately Town Clerk shall mail copies of the resolution and vote to the President of the United States, Donald Trump; the Speaker of the United States House of Representatives, Paul Ryan; the House Minority leader, Nancy Pelosi; the Majority and Minority leaders of the U.S. Senate, Mitch McConnell and Charles Schumer; the U.S. Senators representing Massachusetts, Edward Markey and Elizabeth Warren; the Congressperson representing our district, Jim McGovern; the Governor of Massachusetts, Charlie Baker; the Massachusetts Senate President, Stan Rosenberg; the Speaker of the Massachusetts House, Robert DeLeo; and the state senator and state representative from our district, Stan Rosenberg and Stephen Kulik.

Or taken any other action relative thereto. *Majority Vote Required*
